## **Community Youth Internship Experience Committee**

2022-2023 proved to be a very exciting year for the Community Youth Internship Experience Committee. Our committee membership increased, and we now have a total of six committee members. With the increase in minimum wage, our committee spent much of our efforts this year in fundraising to maintain our ability to subsidize four interns without diminishing the number of hours for each internship.

This year, we were also able to increase our committee's visibility by tabling at the SCALL Institute. We had many opportunities to talk with members, discuss the work of our committee and generate interest in growing the internship program to areas outside of Los Angeles and San Bernardino in the coming years.

Thanks to the support of the entire SCALL membership, we were able to raise just over \$1500. We would especially like to thank the SCALL executive board and their generosity in matching funds in the amount of \$1500 in addition to our committee's annual budget. With these donations, the board's matching funds, and a generous anonymous donation of \$2000 directly to LAEP, we will be able to provide five deserving high school students with rich internship experiences this summer. This year's internship host sites are California Court of Appeal, Law Library for San Bernardino County, LA Law Library, Loyola Law Library, and UCLA Law Library.

The committee thanks SCALL for their continued financial support of these internships. Without SCALL's significant financial support, we would be unable to offer these wonderful experiences and expose local students to law libraries and librarianship.

The GRC continues to monitor legislation and re-post AALL GRC and AALL Government Relations Office postings when relevant. We haven't posted much recently because Emily

There was no call to action for legislation or administrative activity during the SCALL year.

The Chair met with Diane Rodriquez, the new NOCALL GRC chair, at the NOCALL Institute on 10 March. We had a good conversation about our chapter government relations work in California. We don't have any specific plans at this time but will continue to work together.

David McFadden joined the Council of California County Law Librarians in Sacramento on Tuesday, 28 March for their legislative day to ask for county law library funding to be added to this year's budget. This is the first time since 2019 that David McFadden was able to join Sandi Levin of the Los Angeles Law Library on CCCLL legislative day. L.A. county is too big with too many legislators for one person to cover it all in one day.

#### Website

The committee maintains the SCALL website at the scallnet.org domain. Our dedicated IP address is 162.144.185.122. The website is powered by WordPress and hosted by Bluehost. The website has been updated to run on the latest version of WordPress, 6.2.2. It is running Hydrogen theme by RocketTheme. The server is running PHP version: 7.4.33 and MySQL version: 5.7.23-23. The PHP version was recently updated to meet the minimum requirements and is currently supported.

In 2022, Bluehost announced that they would stop supporting older version of PHP and recommended we upgrade our web installation to a supported version of PHP. Last year, an attempt was made to update, however, the website was relying on an older theme (Audacity) and group of plugins that hadn't been updated by their original developers in years, and the upgrade caused a critical error and therefore had to be reverted.

In May, a couple of our web editors started experiencing issues with editing privileges in WordPress. Digging in, it became evident that the issue was the outdated plugins and theme powering the site. As a result, I had to quickly bring the site down, use the opportunity to contact the host and request an update to the PHP (knowing this would fully break the site) and then worked two consecutive nights to dump all the non-functional plugins and theme and rebuild the site. As a result of the new theme and plugins, the site is running much faster and we're no longer plagued by unexplainable errors. All the content on the site is accessible and editors are able to make updates to their pages. All the plugins are up to date, including the ones that were previously incompatible with the former version of PHP, such as the Max Buttons and the events calendar plugin.

In the 2022-2023 year, the committee created 7 new posts on the website, primarily the publication of the Newsletter. Additionally, it published 8 new pages for the SCALL Institute. Routine updates were made to pages that change year over year. We're now also able to post events to the calendar, and two new events were recently posted.

#### Listserv

SCALL maintains a listserv on Google Groups. Our listserv address is scall@googlegroups.com. At present, we have 251 active members on the listserv, which is an increase of 62 new accounts, mostly coming from the SANDALL merger. This listserv is not tied in with the Membership Directory, therefore any changes in membership are not automatically reflected in the listserv. Members must take an additional step to request listserv access or profile update. In an effort to keep the listserv membership reflective of actual active SCALL Membership, the IT Chair works with the Membership co-chairs to annually purge any non-active members from the listserv. Getting added to the listserv is a benefit of membership and all new requests are checked against the SCALL membership directory.

# **Library School Liaison Committee**

The SCALL Library School Liaison Committee's charge is to establish and foster professional relationships with students enrolled in library school programs in Southern California.

- (1) The Committee had eight members this year, including the Committee Chair.
- (2) The Committee continued its mentoring program for library school students living in southern California.
  - The Committee sent emails to local library school students through the UCLA library school listsery, IS-NETWORK, and the SJSU library school list sery, ISCHOOL-SHARE, and geographical SLIS alert inviting responses from library students wanting a law librarian mentor. Additionally, the Committee chair reached out to the Coordinator of Student Services for the Master of Management in Library & Information Science program (MMLIS) at USC. This year, there were four requests for mentors, from three students in the UCLA MLIS program, and one student in the San Jose State University MLIS program. The UCLA MLIS students all reside in Los Angeles, and the SJSU student resides in La Cañada Flintridge. All students were paired with mentors.
  - The mentors answered questions about the profession and provided career advice by corresponding via Zoom, email, or phone with their mentee.
  - This can be compared to last year when two students requested a mentor, and the previous year when we had ten requests.
- (3) This year, the Committee's budget was \$6,000.

- (4) The Committee also continued the SCALL Scholarship program. In February the Committee chair posted the application for the 2023 SCALL Scholarship on the SCALL website and advertised the scholarship on the SCALL listserv, the UCLA library school listserv, and the SJSU listserv and geographical SLIS alert. Additionally, the Committee chair contacted the USC Coordinator of Student Services for the USC MMLIS program. Applications were due on 3/27/23. This year, two applications were received. All eight committee members participated in proposing award amounts for those applicants deserving of awards, and the Committee chair circulated proposed final award amounts which were agreed upon by the committee members. The majority of the Committee determined that both applicants met the scholarship requirements by demonstrating a commitment to pursue a career in law librarianship, and in May, 2023 the Committee announced its decision to award scholarships to these two applicants. We awarded SCALL scholarships to the following applicants:
  - Araceli Argueta (Los Angeles) San José State University
  - Linnea Schuster (San Diego) San José State University

A total of \$6,000.00 was awarded to the two scholarship recipients.

#### **Placement Committee**

The Placement Committee maintains a listing of job openings for the benefit of the SCALL membership and the legal community. Between June 28, 2022 and June 8, 2023, the committee received ads for approximately 68 open positions, down from 87 positions posted in 2021-2022. Each job announcement was posted by Placement Committee members to both the SCALL listserv and to the SCALL "Career Opportunities" web page. In addition, links to current job descriptions on the SCALL Placement web page are provided in the electronic edition of the SCALL Newsletter.

In order to keep the job listings current, inquiries were periodically sent to the contacts of job postings. Each contact was asked whether the ad should continue to be listed on the SCALL Placement web page. The contacts were also asked whether the ad should be included in the next SCALL Newsletter issue. Positions were only listed in the newsletter when express permission was given by the contact.

There are currently 15 jobs posted: 6 from Los Angeles County, 2 from Orange County, 1 from Riverside County; 3 from San Francisco County; 1 from Yolo County; 1 from firms with offices in multiple cities; and 1 virtual.
